Stolen Elections Steal Your Property Taxes



"Elevator Speech" Version

This story starts out with higher math, which is one reason not many people paid attention to the case, even though it's been years in the making. But everyone understands a coverup, such as just happened in Arapahoe County. Nothing says "I have no argument in my defense" like tampering with the evidence, especially when the evidence happens to also be the definitive record of a federal election.

Which gives us an issue that unifies across party boundaries. Because voters in every party agree - we all hate thieves' hands in our pockets. And it turns out we have **no proof Coloradans voted in 2020 to raise property taxes.**



"More Details Please" Version

The May 27th Arapahoe GOP Executive Committee meeting started with Schume Navarro, legislative aide for Brandi Bradley, explaining how besieged Republicans and common sense are at the Colorado Capitol. She said the infamous 1312 bill was actually unifying. Everyone can see what's wrong with unfree speech and violation of beliefs, and that's what happens when one person forces another, under threat of losing a job or parental rights, to use ever-changing pronouns and names.

Even Democrats must be wondering why their party criminalizes free speech and guns and coroners who "deadname" the dead, but assigns minimal penalties for those who do unspeakable things to children. Because we do. Twice over.

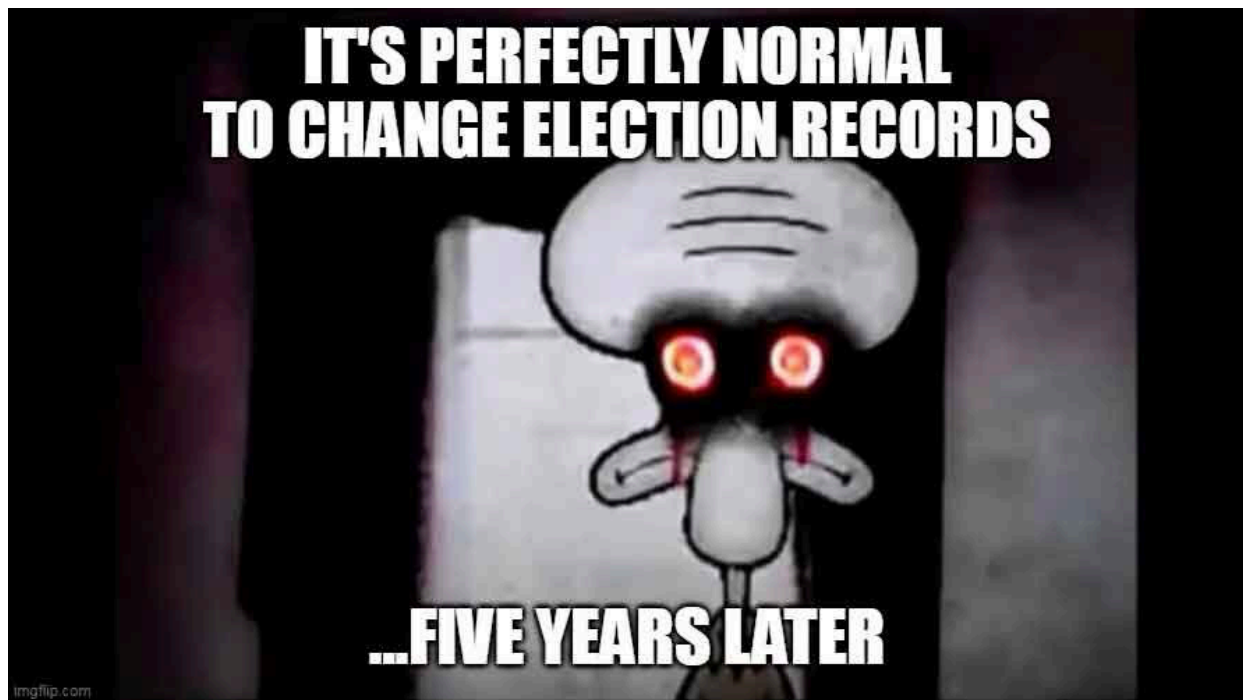
The second speaker, [Mark Cook](#), explained how patterns in Arapahoe's 2020 cast vote record (CVR) matched patterns mathematician Ed Solomon saw in Nevada. Arapahoe citizens complained to the county years ago about this evidence of massive election fraud, but were dismissed as conspiracy theorists. Meanwhile, Ed Solomon helped Nevada resident Andy Thompson launch a case against Nevada, and the Arapahoe CVR was to be evidence in the case.

Until about a month ago when Solomon discovered Arapahoe had changed the evidence, the CVR, which is an election record and never supposed to change, and the new one didn't show the pattern he'd seen. And somehow Arapahoe forgot to mention this to anyone. Until Ed Solomon notified the FBI. Half an hour later, Arapahoe put out a vague, undated, unsigned statement that they changed the CVR because some assistant professor at Yale had advised them of an error.

This means Arapahoe - at best - manipulated the election records twice. The original manipulation showed the mathematical pattern, so it couldn't have reflected the actual election records to begin with. The new version shifted votes within the ballots, which is not only hugely illegal but also disturbing that the county had no barriers to changing election records without notice.

Both CVRs showed Coloradans voting "yes" on Amendment B to raise their own taxes. But both CVRs are visibly falsified records. Taxation without representation has been called tyranny.

Impossible Patterns in 2020

What Ed Solomon saw in Arapahoe County was Trump voters and Biden voters voting almost identically on whether to raise taxes. Of course some Democrats voted for Trump and some Republicans see reasons to raise taxes, but common sense shows that in general, across a county, there would normally be a notable difference between what Trump and Biden voters think of taxes. But not only did they vote the same way, but it stayed the same over time as votes came in, with both types of voters going up and down together. If 50% of Biden voters voted no on Amendment B at one point, 50% of Trump voters did too. If 35% of Biden voters voted no later in the evening, so did 35% of Trump voters. This pattern is not believable.

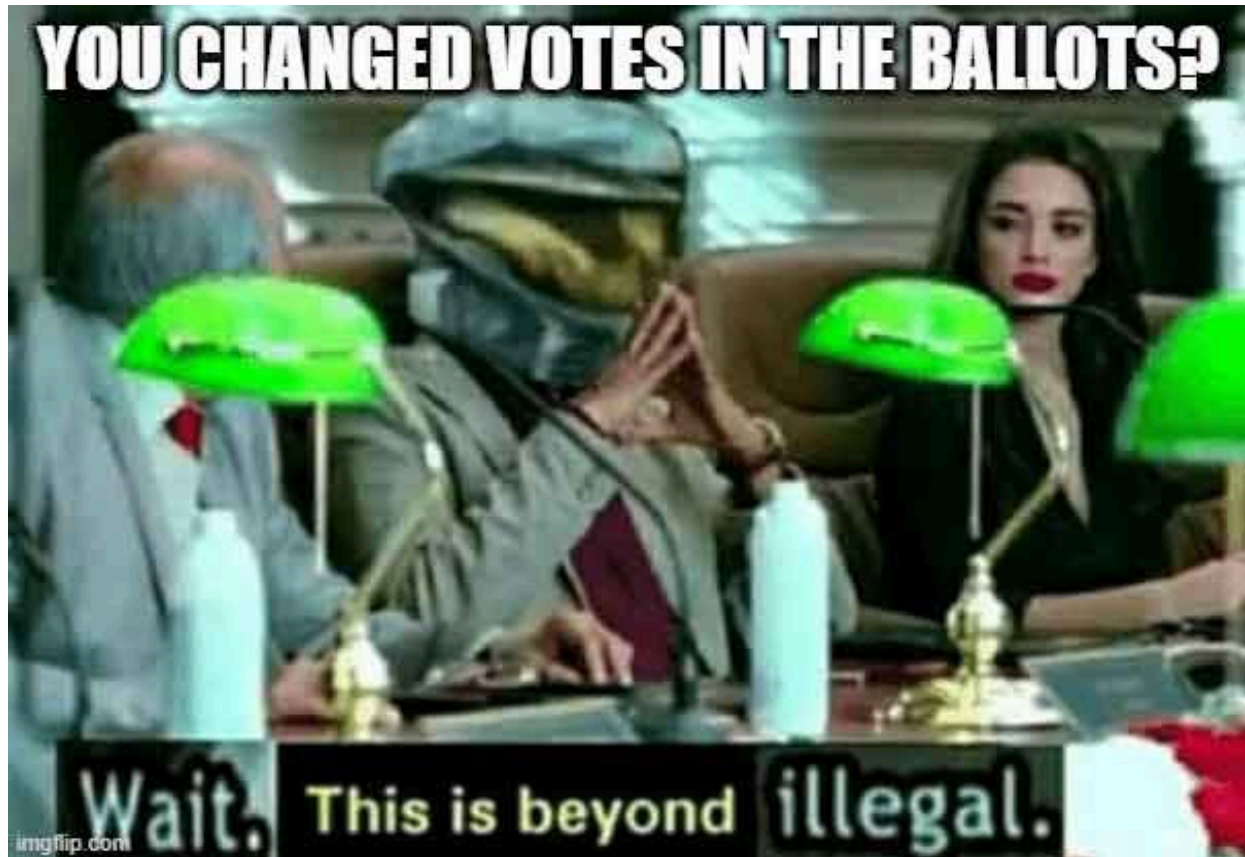


Caught Changing Election Records

The Arapahoe County Clerk and Recorder's Office suddenly discovered a need to change the 2020 election records "on or about October 29, 2024" when they claim an assistant Yale professor, Shiro Kuriwaki, contacted them about an error in the 2020 records.

However, this is also a few days after Arapahoe citizens reminded the Board of Commissioners of all the reasons, including Ed Solomon's findings, that they would not be able to trust 2024 election results. Citizens also emailed information about Solomon's findings to the board, which a board member asked permission to share with the Clerk and Recorder's Office.

Lawsuits

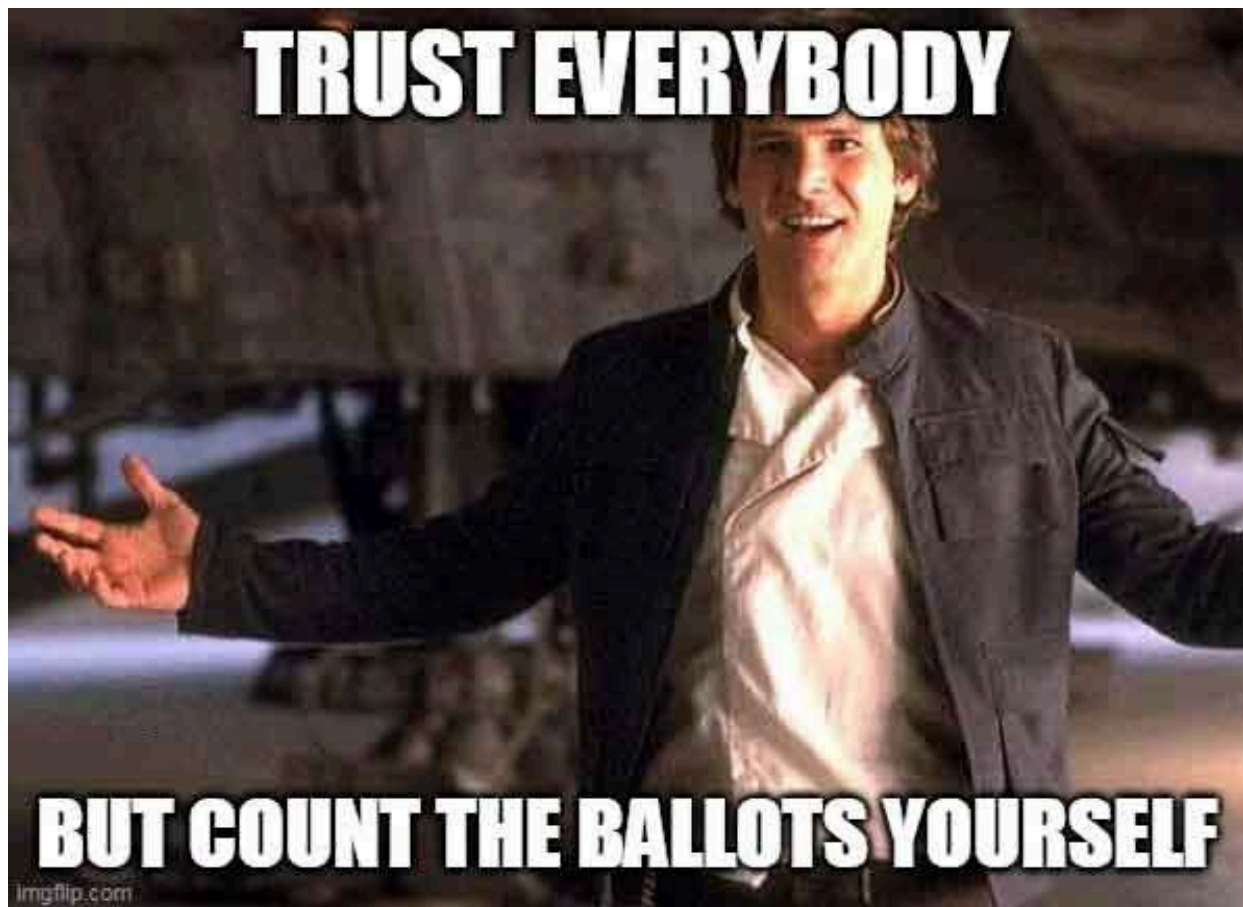

But resignation should not be assumed either to admit guilt or substitute for accountability.
