Arapahoe CVR Scandal Update

We reported on the [CVR scandal](#) when it broke. Now Arapahoe County has offered a response...sort of.

The [county says](#) - without proof - that there was no tampering, no fraud, no conspiracy. Basically, they say it's okay for the public CVR (Cast Vote Record) to be wrong because there is an official CVR, which we won't show you, but trust us, it's okay. And the public CVR is also okay because... "*redaction*." (Redaction is only for very small precincts; why did "redaction" require changing almost every ballot record in the county?)

Interestingly they say, "*The error went unnoticed until October 2024, when we received reports of unusual data patterns in the 2020 CVR.*" Was it "unusual data patterns" as in what Ed Solomon found, or "*redaction error*" as in what the county claims a Yale assistant professor contacted them about? This is an important question, because citizens did in fact notify the county of Ed Solomon's findings in October 2024, and citizens also notified the county years before. So why wait until "unusual data patterns" were to be introduced as evidence in a court case, to make the change?

The county's response continues: "*Unfortunately, recent claims suggest that this formatting mistake was part of a larger attempt to manipulate election results. These accusations are not only false, they are also irresponsible and harmful.*" This is a statement, not proof. Where is the math wrong? How is it irresponsible to ask where the math is wrong? Does the county lack the expertise to publicly refute Solomon?

"*A CVR cannot be used to alter votes or manipulate outcomes.*" Of course not. Data doesn't manipulate itself. The question is, who manipulated the CVR to scramble votes across ballot records on the definitive public record of the election? How easy is it to change that

record'? How did the county dare change it with no prior notice'?

"The original CVR used for auditing and certification remains unaltered and was submitted to the Secretary of State as required." Is that so? We are talking about taxes; proof is required. The public entrusts the county clerk with elections, the most valuable infrastructure in America - the keys to our government. The public has the right to demand proof. The clerk must somehow meet that burden of proof by finding a way to demonstrate it beyond doubt that the original CVR is correct and unaltered. **Or else refund the property taxes.**

The county concludes by complaining about "*intimidation of election officials*." Election officials intimidated by questions should probably seek another profession where every word is pleasant and affirming. Has the county forgotten its own [org chart](#)? Citizens are in charge; the clerk's office does not get to baselessly accuse citizens of falsehood and lecture citizens on how to be nice.

Meanwhile, Ed Solomon invites anyone to check it out for themselves and [replicate his results](#); the patterns show up not only in Arapahoe but also in El Paso and other counties. "In fact, El Paso and Mesa Counties are the worst offenders in each election cycle, [worse than Arapahoe](#) by orders of magnitude," says Solomon.



Nevada Case Update

Solomon believes the Arapahoe CVR swap was intended to frame him for perjury in the Nevada case *Thompson v. Nevada Secretary of State*. If so, the discovery of the changed CVR foiled that plot.

But now the Nevada judge who could have noted Arapahoe County tampering with evidence across state lines and ruled on the merits of the case, has instead suddenly dropped the case. Solomon does not fault the judge, but rather the [people of Nevada who did not support the judge](#) against the Deep State.

However, the judge's [order appears highly vulnerable](#) to appeal or challenge (the plaintiff did not receive a hearing, which violates basic due process rights), and the plaintiff is appealing.

We could have already been holding people accountable. Arapahoe County must learn a lesson from Nevada. As Churchill said, "Never yield to force; never yield to the apparently overwhelming might of the enemy."

Lindell Trial

Eric Coomer of Dominion sued Mike Lindell for defamation (he has sued more than 20 people who asked questions about elections.) The trial was held in a US District Court in Denver in June. Many Arapahoe Republicans showed up during the trial to support Lindell. Coomer's lawyers tried to tie Lindell to statements that "Eric Coomer rigged the election", but since Lindell didn't even know Coomer until he got sued by him, the jury didn't seem convinced. A lot of information on election fraud including the [Arapahoe CVR scandal](#) made it into the court record.

The jury found Mike Lindell liable for just \$440,000, and FrankSpeech liable for \$1.8 million, out of the \$62 million Coomer asked for. Lindell was found not guilty of intentional infliction of emotional distress or civil conspiracy against Coomer, and his company MyPillow was declared to be completely innocent.

The best and most detailed reporting was by [AsheinAmerica](#) who posted [threads summarizing each day](#) she was able to be in the courtroom.





Tina Peters

While some would like to “move on” or “let go” of past election controversies, interest and intensity around the issue continue to grow. Colorado remains in the national spotlight on this issue after imprisoning former Mesa County Clerk Tina Peters. In a letter dated May 12, the U.S. Department of Justice (DOJ) requested extensive voter and election-related data from the Colorado Secretary of State’s office. Per a Denver Post article dated June 18, 2025, both Jenna Griswold (Colorado Secretary of State) and Matt Crane (Executive Director of the Colorado County Clerks Association) believe that this comprehensive request is a “fishing expedition” to help Tina Peters.

In the Denver Post article, Tina Peters is labeled an “election denier” who was convicted in 2024 of “using someone else’s security badge in spring 2021 <as Mesa County Clerk and Recorder> to give access to Mesa County’s elections system to a third party.” Peters’ defense was that she was seeking to preserve the county’s election records. Colorado law and state regulations require county clerks to back up their election data as part of overall election security and record retention protocols.

Peters was convicted on seven of ten charges and was sentenced to nine years of incarceration by Mesa County Judge Gerald Wood, who could not hide his vitriol toward the defendant. He labeled Tina Peters as a “danger to our community,” and claimed that her lies, selfishness, expense and breach of oath to the county were “immeasurable.” Therefore, prison could be her only appropriate punishment. This harsh treatment was deliberate: it was meant to scare and silence any other Colorado county clerk who might dare to challenge an order by Secretary of State Griswold. It could also have been meant to break Peters’ will to stand for her convictions. However, this judge’s approach has backfired. It has instead fueled a steel resolve in Tina Peters and ALL Americans who desire election integrity. And their persistence in pursuing truth is beginning to pay


off.

Peters has filed an appeal of her convictions, but in the meantime, she has been serving time in two detention facilities and is now in state prison. NEXT WEEK (July 22) in Denver, Peters' lead attorney will present oral arguments before federal Magistrate Judge Scott T. Varholak (who is handling all aspects of Tina Peter's ongoing legal proceedings) explaining why Peters should be released on bond while her appeal is pending. See the "Urgent Call to Action" (below) encouraging concerned citizens to fill the courtroom at this hearing as a show of support for Tina Peters.

Meanwhile, Griswold and Crane are reportedly worried that the DOJ's written request for election records would expand what would be considered "an election record to back up Peters," per the DP article. Interestingly, the letter came a week after President Donald Trump referred to Peters on Truth Social as a "political prisoner," calling for her release by Governor Jared Polis. Additionally, in January the DOJ filed a "Statement of Interest" in Peters' case, indicating the agency's interest in her conviction. A "Statement of Interest" is a formal legal document filed by a government entity in a court case in which the government is not a direct party, but where it believes the outcome may affect federal interests, including constitutional rights or federal criminal statutes.

Public opinion on Tina Peters is quickly shifting. Prior to her trial, approximately 750 articles slandering Peters made the front page of the Grand Junction Daily Sentinel. Consequently, the jury pool for her trial was unfortunately tainted. Today, industry experts like Dr. Walter Daugherty, a Harvard-trained computer scientist, and professional mathematician Ed Solomon agree that Tina Peters was right to back up and investigate the election machine results in Mesa County. Tina is paying a heavy price in her stand for election integrity, but her sacrifice is monumental in helping expose corruption and election fraud. The day will come when every

corruption and election fraud. The day will come when every American knows her name. We thank God for this brave Coloradan, Gold-Star Mom, and public servant. Please be encouraged to keep her in constant prayer while she is suffering for our sake.



Hand Count Party Game

“Hand counting” is short for transparent election systems understandable by the average citizen. Hand counted generally means elections which are one-day, in-person, ID-verified, with paper ballots cast at the precinct level and hand-counted where cast.

Most hand count systems result in double-checked, auditable, final results publicly available on Election Night. Hand counting is simple, cheap, fast, and fun! So fun, in fact, that training can be done as hands-on hand count experience disguised as a party game!

So download the files and invite some friends over this summer to do something to save our country - show them how we-the-people can count our own votes. No guarantees this is the funnest game ever (but it could be - you won't know till you try!) But this is how we prepare for President Trump's EO on elections, by building up an Arapahoe army of hand counters.

How to play. This is absolutely serious. Fun shall not be had by anyone.

ACGOP Executive Committee (ExComm) Meetings



EVERY SEARCH OF
ELUSIVE GOLD

"Ever in Search of Elusive Gold:" There were stories of gold in Colorado far back enough to motivate [Zebulon Pike](#), and Colorado gold was first discovered in Ralston Creek in present-day Arvada around 1848, the time of the California Gold Rush.

But the real discoveries that kicked off Colorado gold fever were ten years later by the Green Russell party, in Arapahoe County. [The Big Dry Creek placer](#) of 1858 was near the intersection of University and Arapahoe, where the Highline Canal now crosses Dry Creek going into DeKoevend Park. Another 1858 placer is shown a bit further upstream in the Cherry Knolls Park area. It was in July, 167 years ago, when the [first significant gold discovery](#), worth about \$44,000 today, was found in the [Little Dry Creek Placer](#) near Arapahoe and Holly.

The 1858 "[Mexican Diggings](#)" along the Platte as far north as Alameda Road, were in Arapahoe County for forty more years before becoming Denver, but another early site is still just within the border of Arapahoe County, where Dartmouth crosses the Platte. On the other side of Arapahoe County, in the [area of Foxfield](#), gold was also discovered up Cherry Creek.

Stories of gold in Arapahoe County sparked the [Colorado Gold Rush](#) of 1859, inspiring the motto "Pike's Peak or Bust" as miners soon realized that even richer deposits lay farther west - in the legendary "them thar hills."
